All entries must be hand-carried to the Veteran's Building at the Southern NM State Fairgrounds and Lots 1-7 and 9 MUST BE READY FOR HANGING. Wire and screw eyes are recommended to enable the item to be securely hung. Glued or taped hanging materials are not recommended and the exhibitor takes full responsibility for unsafe hanging materials. Be aware that items are hung on peg board. Excessively heavy items are entered at owner's discretion however the SNMSF claims no responsibility if item is damaged from a fall.

Those who wish to pick up their entries early will forfeit their ribbons, cash prizes and gift certificates. Works not picked up at this time shall become the property of the Southern New Mexico State Fair & Rodeo. **ENTRY STUBS ARE REQUIRED FOR RELEASE OF EXHIBITS.**

FINE ARTS & CRAFTS General Rules:

1. **ELIGIBILITY:** This show is open to any artists living in the Doña Ana, Bernalillo, Catron, Grant, Hidalgo, Luna, Otero, Sierra, Socorro, Valencia and El Paso Counties.
2. All works must be that of the exhibitor and never before exhibited at the SNMSF&R
3. Any item deemed by the Superintendents to be in bad taste will not be accepted.
4. If an item is accepted and is later determined to be in bad taste, it will be judged but will not be displayed.
5. **JUDGING:** Exhibits will be judged Tuesday of the Fair week. All entries will be judged on creativity, technique, and execution. Judges are NOT REQUIRED TO AWARD ALL PREMIUMS\OR RIBBONS. All decisions of the Judges are final. There are no refunds of entry fees. Late entries will be accepted for display only and will not be judged or eligible for awards.
6. New Lots and Classes may be declared, changed or combined at the discretion of the Superintendent or Judges, to aid in the separation and judging of entries.
7. **SALES:** Any artist wishing to sell their entry during the fair will be given the opportunity to do so. 20% of the sale will be charged as a COMMISSION FEE FOR SALES MADE AT THE FAIR.
8. Please be courteous to all Veteran Building volunteers. Without their donation of time, this competition would not be possible!
9. Failure to meet or follow any of the above-mentioned rules will result in instant disqualification!
10. **LIABILITY:** The Southern New Mexico State Fair and Rodeo holds no liability for loss or damage to any entry/exhibit during the course of the fair. However, attendants will be present whenever the Veteran's Building is open and due care will be shown to all entries. Entries not picked up during the General Exhibits Release time will become the property of the SNMSF&R to do with as they wish.

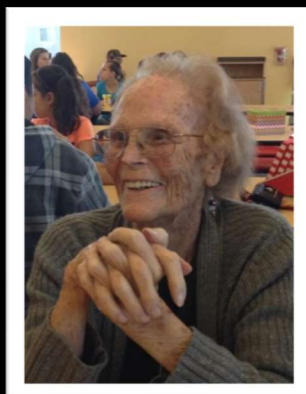
