### **EXPECTATION STATEMENT**

As a contestant in the Southern New Mexico State Fair & Rodeo (SNMSF&R) Royalty Pageant, I understand that should I win the title of SNMSF&R Fair Queen/SNMSF&R Fair Princess/SNMSF&R Fair Jr. Princess/SNMSF&R Fair Pee Wee Princess/SNMSF&R Rodeo Queen/SNMSF&R Rodeo Princess/SNMSF&R Rodeo Jr. Princess, I will be the SNMSF&R official representative and responsible in representing the SNMSF&R to the general public.

I will strive to represent exceptional sportsmanship, high moral and ethical character and speak intelligently with the knowledge of the SNMSF&R and Southern New Mexico.

I understand the SNMSF&R Royalty Pageant is not a beauty contest, but is a competition which recognizes a number of attributes: sportsmanship, horsemanship, personality, public speaking, and appearance. Therefore, it is my responsibility as the Southern New Mexico State Fair & Rodeo's official representative for my division to act, speak and dress according to the esteem my title deserves at any time that I may be in the public eye.

- To wear my crown, hat, buckle, sash and official shirt when appropriate and any time I am acting in the capacity of my title;
- To attend specific scheduled events as requested by the SNMSF&R Royalty Committee. That my official appearances must be approved by the Royalty Superintendent and I agree to maintain close contact with her and the committee to accomplish this;
- By submitting my entry form and this Expectation Statement, I acknowledge this as the contractual agreement between the SNMSF&R Royalty Pageant and myself;
- To uphold my title, encourage others to participate in future pageants, and to assist in the promotion and production of the pageant in every way;
- If chosen as Southern New Mexico State Fair Rodeo Queen, I will have the opportunity to compete in the New Mexico State Fair Queen Pageant in the year designated by my title and will do everything possible to adequately prepare myself for the competition;
- That during the term from my entry as a contestant and through my reign, I will remain unmarried and not bear any children. I shall observe high standards of moral and ethical character.
- That I am a non-paid contestant and participant in the SNMSF&R Royalty Pageant. I am aware that my title does not receive any salary and that my expenses throughout my reign are my responsibility.
- I hereby release the sponsors, the SNMSF&R Royalty Committee, and the SNMSF&R Fair Board from any claim for damage or liability as a result of an accident or injury which may occur while participating

in or traveling to any event required in the SNMSF&R Royalty Pageant activities and/or during my reign.

I also release the right, title, and claim of photography that may be taken by the SNMSF&R Royalty Committee or any official photographer for their future use.

I have read this Expectation Statement and the accompanying Waiver of Liability and fully understand and agree to abide by the terms therein. I hereby state, for myself, my parents, legal guardians, and helpers, that I have read and understand the SNMSF&R rules and agree to abide by said rules during official SNMSF&R activities.
