**TITLEHOLDER CONTRACT**



I hereby agree to abide by the following rules placed before me by the SNMSF&R Royalty Committee and the SNMSF&R Fair Board. I realize as a representative of the SNMSF&R I am expected to conduct myself in a manner that reflects well on the SNMSF&R as well as myself during royalty events and in my personal life. To clarify expectations, they are as listed below.

- **Inappropriate Language-** No profanity will be tolerated. If you are heard during your reign using profanity, appropriate action will be taken.
- **Drinking/Smoking/Consuming Legal/Illegal Drugs:** Possession or consumption of alcoholic beverages, harmful non-prescription drugs, and recreational drugs are prohibited (i.e., cigarettes, e-cigarettes, and cannabis are not allowed). Court members must not have and/or had any criminal charges filed against them, including royalty over 21 years of age.
- **Respect of Property-** Participants will show respect for the property and facilities used during events and will assume financial responsibility for any damages caused.
- **Excused Absences-** Your contribution to this program through your active participation is highly valued and your obligation to this program should be your top priority over other activities. Participants are allowed three (3) excused absences during their reign. (Examples of excusable activities: school extracurricular activities, family emergencies, 4-H, FFA, Gymkhana, Rodeo, and work). More than three (3) absences may be cause for removal of your title.
- **Attire-** Clothing should be neat, clean, in good repair, with no rips or stains. Clothing should be fit and appropriate: no short shorts, revealing tops (cleavage or abdomen showing), or overly tight-fitting shirts or pants. During events a well-groomed appearance is an absolute must, this includes: Clean, natural colored, curled hair (if hair is long enough to be curled) and age-appropriate makeup along with well-maintained fingernails. Clean hat and crown, belt, belt buckle, and polished boots and designated outfit. **NO** chewing gum, sunglasses, cell phones (visible) will be acceptable during official events. Remember, you are representing the SNMSF&R whether you are in an official capacity or in your personal day-to-day activities.
- **Attitude-** Be friendly and courteous to people making them happy to be around you. You are a role model to others and must always conduct yourselves like young ladies. **SMILE!!!** Holding the title and prestige of the SNMSF&R Queen or Princess is an honor and should not be taken lightly. Inappropriate interaction/behavior with members of the opposite sex will not be tolerated. **No kissing, holding hands, or showing affection of any kind with others during activities.** People are watching and judging you, so always “make good choices”.
- **Social Media-** Remember again, you always represent the SNMSF&R throughout your reign and any inappropriate pictures and/or information, detrimental to your title will not be tolerated and will be monitored. You will be asked for access to your personal social media sites (i.e.; Facebook, Instagram, X, Snapchat, TikTok, etc.) for monitoring purposes throughout the

reigning year. All postings with sash and crown are to be of events and as a promotion of the SNMSF&R.

- **Grievances-** All grievances must be put in writing and submitted to the Royalty Superintendent, Kaylee Garrison. A meeting to discuss the grievance with all concerned parties will be scheduled and a resolution will be determined.

If I break this agreement, the following disciplinary actions may be taken:

- Upon first offense:
  - I may be sent home immediately from the activity or event.
  - I will be given a verbal warning or correction for the first violation.
- Upon second offense:
  - I will be given a written warning to document the action of a second offense.
  - A meeting may be set up with parent/guardian and the SNMSF&R Royalty Committee to discuss actions within two weeks of the incident and those involved must make necessary accommodations to attend.
- Upon third offense\*\*\*:
  - My title may be removed after proper review of violation, and I may be released from future representation of SNMSF&R Royalty. As a result, all property (i.e., crown, buckle, sash, official long sleeves/polo, jacket, breast collar, saddle, purse, etc.) of the SNMSF&R will be returned to the Royalty Superintendent, Kaylee Garrison.
  - I may be banned from future pageants if the SNMSF&R Royalty Committee feels indicated.
- NOTE: I understand that the consumption or use of alcohol and/or legal/illegal drugs (to include cannabis and tobacco) by a minor is against the law, and I know I may be reported to the proper authorities. As a minor, should I be seen with any alcohol or drugs (with or without official attire in person or via social media), may be grounds for immediate termination of my contract.

**\*\*\*Depending on the nature and severity of the violation of this contract, a first offense may be grounds for immediate removal of title and all prizes/property returned to the SNMSF&R Royalty Committee.**

I acknowledge that as an adult, I should model positive behavior and lead by example. I understand that my behavior can affect my child's reign while being a SNMSF&R Royalty Titleholder.
